

MINUTES OF A REGULAR MEETING OF COUNCIL

CITY OF GARFIELD HEIGHTS, OHIO

Monday, November 23, 2015

MEETING CALLED TO ORDER AT 7:00 p.m. by Council President Joseph Suster.

INVOCATION BY: Councilman Eugene Glenn

PRESIDENT SUSTER: Roll call please.

ROLL CALL: **PRESENT:** Council Members Dudley, LaMalfa, Nenadovich, Glenn, Suster, Burke, Vaughn

READING AND DISPOSAL OF MINUTES:

PRESIDENT SUSTER: Reading and disposal of the Minutes.

CLMN BURKE: Mr. President, I would like to make a motion that we accept the Minutes of the Regular Meeting of Council, City of Garfield Heights, for Monday, November 9, 2015 as written.

PRESIDENT SUSTER: On the motion made by Mr. Burke to accept the Minutes of the Regular Meeting of Garfield Heights City Council as of November 9, 2015, all in favor signify by saying Yea. All opposed?

AYES: Burke, Dudley, LaMalfa, Nenadovich, Glenn, Suster, Vaughn
That passes with 7 Yes votes.

WRITTEN COMMUNICATIONS TO COUNCIL:

PRESIDENT SUSTER: I'd take this as far as communication goes. We had a couple that has requested an appeal regarding a Zoning Board decision. Is there anybody here that would like to speak on that this evening? Yes, Ma'am.

Linda Zsilko, 4725 East 86th Street. I don't know where to begin. I've lived in Garfield Heights for 23 years. I have a neighbor, Mary, who has lived there longer than I have. I damaged my fence during the summertime and after I damaged the fence, it was not fixable. So I replaced the fence. Prior to my replacing the fence, I used to call to the Building Department in which I explained the whole situation to the girl who answered the phone as to I damaged the fence, I cannot fix the fence and I was going to replace the fence. I wanted to replace it with a 6' high shadow box fence and it would go exactly where the existing fence that was damaged was. She told me that there shouldn't be a problem with that so we purchased the fence and we put the fence up. Mary, who is our neighbor, had been taken out and taken to the hospital and then a nursing home for three months in between this damage of the fence so when I called to find out if I needed what was allowed and told that it was OK to put the fence up. Mary and I have had a wonderful relationship as neighbors; have been at birthday parties, baby showers, graduation parties. She has allowed us to store our motorcycle in her garage and asked if my children

could bring in her garbage cans because she is housebound and has been so for a while. She has called my husband Steve for handiwork around her house, which he gladly did for her, weeded her gardens, watched her house. She would then suggest that our children park their vehicles in her driveway to show that there was activity going on in her house. There was no problem. After Mary came back from the nursing home it was my understanding that she was going to have a health aide that would come into the house and care for her, by a friend who I had spoken to. When Mary came home from the hospital I received a text message from her daughter asking me- there wasn't an asking- she kind of told me that I was going to be her mother's caregiver and when I explained to her that I have prior family things going on. I have a father who is 90 who has lung cancer. I am his caregiver. I have two children that are getting married. I have a grandson that lives in my home with me and I just could not make that commitment. In her text message she told me it was only for 10 minutes a day. There's no way 10 minutes a day I would be comfortable going in and being her caregiver. She's housebound.

PRESIDENT SUSTER: Let me ask you a question before you go on. What does this have to do with the fence?

MRS. ZSILKO: I'm sorry. I'll get to that. After I told her daughter that I was not going to be her caregiver that is when the fence situation arose. I truly believe had I agreed to be her mother's caregiver that I wouldn't be standing here right now. That became a problem because of that refusal to help. Up until that point there was not one problem with my neighbor.

PRESIDENT SUSTER: Do you have anything else?

MRS. ZSILKO: I would like to also say that with that fence being up I do feel more secure. I have my grandson playing in the back yard and it gives me a greater sense of security. I have noted on many occasions there's a cut through. The neighbor her yard does not have a fence and for probably a good year because I sit in the back. I have a family room in the back and see people cutting through that yard. Makes me feel uneasy having people cut through like that. Thank you.

CLMN DUDLEY: Mr. Chairman, may I ask one question? On the daughter, you said the daughter told you that you couldn't store the stuff there no more. Two part question. Do the daughter reside in the city of Garfield Heights at that home?

MRS. ZSILKO: No, Sir.

CLMN DUDLEY: Second of all do the daughter have some type of Power of Attorney saying that she's making that decision on the mom's behalf? Because we would never know actually.

MRS. ZSILKO: Not to my knowledge. No.

CLMN DUDLEY: Thank you, Mr. Chairman.

PRESIDENT SUSTER: OK. At this time, I would like to take a vote to uphold the Zoning Board's decision. Does everybody understand it? To uphold the Zoning Board's decision.

CLMN GLENN: To clarify, a Yes vote would uphold and a No vote would rule it down?

PRESIDENT SUSTER: Right. OK. All those in favor signify by saying Yea. All opposed?

CLMN DUDLEY: My vote is Nay.

LAW DIRECTOR TIM RILEY: Mr. Chairman, Point of Order. You might want to take a roll on this just to make it clear for the record.

PRESIDENT SUSTER: OK. We'll start with Mr. Dudley.

CLMN DUDLEY: Before I vote, I wanted to say that I honestly believe that your failure to be wanting to be a caretaker is the reason why you are not being allowed to have that fence up. What I'm saying has to strongly be taken into consideration. I have all the respect in the world for the Zoning Board, but I'm saying in this case right here if the daughter lived here like I said before, Mr. Chairman, and she was a resident here then I would be OK with her decision. She lived there. If she have some type of piece of paper saying that's her mama's decision. But there's nothing showing that this was the mother's decision to tell you all that you all could not keep that fence up when you was told that you was. I just don't see nothing in writing for that. With that, I have to vote in your favor and I say Nay.

PRESIDENT SUSTER: OK. Council has decided that the Board of Zoning's decision will stand as is.

LEGISLATION OUT OF COMMITTEE: None.

REPORTS OF THE MAYOR AND DIRECTORS:

PRESIDENT SUSTER: Mayor, do you have a report for us this evening?

MAYOR VIC COLLOVA: Yes, Mr. Chairman. I do. Thank you. I wanted to start off tonight's report by reading a letter that I received from a resident regarding the safety forces of Garfield Heights. It says:

%Dear Mayor Collova:

I am writing this letter to honor members of our Garfield Heights safety forces. My husband Terry passed away very suddenly last November 4th. He apparently died in his sleep. I frantically called 9-1-1 and was helped immediately by the dispatcher who took the call. I do not remember her name. Police Officer Pat Hayes was the first person to come to my aid. He calmed me immediately and was kind enough to call my sons and my school where I am teaching. He stayed with me the entire time and was very kind and consoling. I would also like to thank the EMS crew that came soon after. They were called Melissa Stepka, Dave Cost, Steven Chocholski and Lt. John Schluk. They were very gentle in telling me that my husband had died. These fine members of our community should be commended for going above and beyond the call of duty to console me on that very awful morning.+

Her name was Carla. I'm not going to say her last name because I don't have the authority to say her last name but I want to say that this is really great. She also put:

%S. I grew up in Garfield Heights and I've lived in my home for 30 years.+

It's surely not great that she lost her husband. That's a terrible tragedy, but this is a good thing. This is what the Police and Fire Departments are all about. We talk to them about giving tickets for this, etc. but this is when they really come into play. I want to commend your guys and the Fire Department for a great job once again, as usual.

Also, I want to report on the Court Community Service. August to October 2015, they worked 52 days. They cleared 339 sites. They put in 1,449 man-hours. They filled 398 bags of trash. They threw out and picked up 49 tires. They filled a 40 cubic yard trash to dumpster and they worked 6.5 sites per day. This is the new program that we put together earlier this year. It's working great. To give you an idea, they took 48 tires from behind the Pet Supply Plus, a 24 yard dumpster from old Ceo's Bar, 398 bags of trash includes weekly litter pickup from 14 sites and they worked 88 days through to October. This is a great program that we approved Council and the Administration. They are doing a great job. If you have sites in your Wards that need cleanup; that need special attention, get a hold of me. I will contact Vince Liotta who heads this crew up and we'll get them working on those sites. They're doing a great job and I appreciate that.

Next I want to reach out and thank 1-888-OHIOCOMP. Once again this year and it's about the 5th or 6th year in a row, they have given us 200 turkeys to pass out to the needy of Garfield Heights. That is being done as we speak for Thanksgiving. Kathy Parssons is heading up that program. They do a great job. This is a great thing that they do for us so we can help the needy in Garfield. I certainly thank everybody involved at 1-888-OHIOCOMP for their help.

I want to talk about the Christmas Lighting Ceremony. Sunday November 29th, this Sunday, 5:00 p.m. here at the Civic Center. Music indoors at 5:00 p.m. Outdoor lighting ceremony at 5:30 p.m. Santa Claus will arrive on a fire truck so you can meet and greet him. Isn't pretty sure Santa's coming, isn't he, Mike?

CLMN NENADOVICH: He'll be there.

MAYOR VIC COLLOVA: That's what I like to hear. We're going to have pictures with Santa, refreshments indoors following the lighting session. There's going to be the Unique Gift and Card Shop open after the lighting ceremony. Residents and recreation season pass holders will be admitted to a free ice-skating event from 6:00 p.m. to 8:00 p.m. I know that breaks your heart to hear "Free", Bob, but. Proof of residency required. You have to be a resident. Children must be accompanied by an adult. Santa will be there also. We do this every year. This is a great time. We get a lot of people here. It's a good chance for people to enjoy the beginning of the holiday season, celebrate Christmas. We're looking forward to seeing you on Sunday. It's really a great tradition. To see those lights go on and to see what our Service guys have done to really light this city hall up is great. I appreciate everybody coming to that.

Next, let's don't forget about the Holiday Lighting Contest. Nomination deadline is 4:00 p.m. December 15th. Please submit nominations by mail to Garfield Heights Civic Center or e-mail jduber@garfieldhts.org or fill out one of the forms and turn them in at the desk downstairs. We have done this every year for the last five or six years. We want to appreciate the people out there that decorate their homes. Some of them really go above and beyond. Really makes the city look great. We believe they should be rewarded. We pick one from each Ward that our judges think had the best display and then we pick one grand winner from that and they are all recognized so continue to look for those people if you would.

I want to talk about a program that I heard of. Veterans Day is a great day every year. We celebrate it here. We honor the Vets. In many areas in recent years they honor at different restaurants, different people do things that we all get involved in. I think it's a great thing because the Veterans certainly deserve to be honored. This year there was something done that I never heard before. Clmn Glenn brought it to my attention and I can't say enough about this. It really touches me and I think it touches everybody. The Garfield Heights Middle School did something really special this year. Mr. Glenn, I'm going to give you an opportunity to talk about this if, Mr. Chairman, you don't mind?

PRESIDENT SUSTER: Go right ahead.

CLMN GLENN: Thank you, Mr. Mayor. First of all, I'd like to get all the participants up in front please. Come forward. I want to start out by saying that Veterans Day means something. I am a disabled Veteran. On that day I went down to Applebee's. They gave a free Veterans Day meal. It was a nice day. They had a lot of Veterans down there that were dressed in uniform. WW II, Korean, Viet Nam, Afghan, Iraq- a lot of Veterans down there with common goals and thinking. At the end of the meal I paid my bill. The waitress came over to me and gave me this thank you card. I'd like to read this card aloud. It says:

%Dear Veteran:

Thank you for serving our country. You are allowed to have a free and wonderful country. I hope that you could write back to me someday. Did you serve in Viet Nam War? Or were you in the Army during 9-1-1? Thank you for keeping us safe all these years.+

This was written by a student at the Garfield Middle School, Anthony Hemel. At this time, I want to recognize the teachers and everybody involved. Is Stephanie Hastings here? She's not here. Stephanie is an old neighbor of mine of years ago. I know her very well. I contacted her first at the middle school. How about Julie Bell? Julie, thank you. She is Anthony's teacher. Is Ms. Porter? You're the letter writer. So you helped Anthony write the letter. Ms. Skerl? Ms. Skerl is a Veteran. A 10 years Veteran. Army, I hope? And Anthony, raise your hand. I want to thank you, Anthony. That was a nice thing you did.

MAYOR VIC COLLOVA: Before you sit back down there's a young man there. What's his name? Thank you very much. This is something that really means something to Veterans. It should mean something to the entire country. We appreciate what you did very much. You went above and beyond. This is what our students in Garfield Heights are really all about. We thank you very much.

CLMN GLENN: Are you a parent or a teacher? Thank you, Chris.

MAYOR VIC COLLOVA: Thank you Mr. Glenn. Before I get into tonight's legislation I'm really looking forward to seeing everybody at the lighting ceremony Sunday. It's something that this entire community can be proud of. It's a time when we put everything behind us and enjoy each other and enjoy the community for what it really is. I'm looking forward to seeing everybody. I also would like to say Happy Thanksgiving to all of Council and to all the residents of Garfield Heights. Have a great Thanksgiving.

With that I'm going to get into tonight's ordinances. Ordinance 52 is the Second Reading. I talked about that at the last meeting, about the fences.

Resolution 24-2015. This is an appointment to replace Valerie Schwonek as a member of the Civil Service Commission of the city of Garfield Heights. This commences immediately for the term ending December 31, 2020. Frank Przybojewski, is he here by any chance? OK. Frank is going to replace Valerie. Just to explain to you a little bit about Civil Service, Civil Service is three members. The three members can't all be of the same political background. They can't be three Democrats. They can't be three Republicans. They have to be a mix. So we have to have two and one. Fortunately we have two Democrats and Frank. Frank will be the Republican on this board. This board really is involved with the testing for the police and fire when we bring young men in to be tested. They work on the test, the testing companies, young men and women. So Frank will do a good job. I don't know the man personally, but he came from great references and I spoke with him on the phone. I'm looking forward to having him join this.

Ordinance 32-2015. We're honoring the memory of Evelyn Hubert who recently passed away. On behalf of the residents of Garfield Heights we want to honor Evelyn. This is one lady that did it all. She graduated in 1940 from Garfield Heights High School. She actually graduated with my father-in-law, Jack Donovan. A few years later, my father-in-law, Jack Donovan, became Mayor of the city of Garfield Heights and he appointed Evelyn as the first lady Clerk of Council that was ever in Garfield Heights. That was quite a deal. She has been involved in everything. She really has. On her 90th birthday I was invited to celebrate a party with some friends of hers and she was as sharp as sharp could be. You would never have guessed she was 90 years old. When you read this legislation you will see how many things she's done for the city of Garfield Heights. Our deepest sympathies go out to the family of Evelyn Hubert. We're going to miss her. There's no question about it. With that, Mr. Chairman, you have my report.

PRESIDENT SUSTER: Thank you. Is there any questions of the Mayor on his report? Is there any questions of the Mayor on his report? There being none, we'll move on to Law Director, Tim Riley. Do you have a report this evening?

LAW DIRECTOR TIM RILEY: Thank you, Mr. Chairman, I have no report tonight.

PRESIDENT SUSTER: OK. Thank you. Acting Police Chief Bob Byrne. Do you have a report this evening?

ACTING POLICE CHIEF ROBERT BYRNE: Thank you, Sir, no I do not.

PRESIDENT SUSTER: OK. Service Director Tim McLaughlin. Do you have a report this evening?

SERVICE DEPARTMENT DIRECTOR TIM McLAUGHLIN: Yes, I do. Thank you, Mr. President. We are currently just going to be able to hopefully by Wednesday finish up a second time through the city with the leaf pickups and try for the third time through. I don't know how far we'll get. It will depend on the weather. We usually get into the first week of December and we're done. We're going to try to make another run through the city.

The other four guys have been working on the Christmas lighting. That's all I have going on now. That's it.

PRESIDENT SUSTER: Thank you. Are there any questions of Mr. McLaughlin on his report? There being none we'll move on to our Parks and Recreation Director, Bob Dobies. Bob, do you have a report for us this evening?

PARKS AND RECREATION DIRECTOR BOB DOBIES: Mr. President and Council Members, good evening. Being as I wasn't here, yes, I do have a report. First of all congratulations on your election and re-elections everybody on Council.

We had our Halloween Skate back on October 30th and we just had a Cosmic Skate last Friday. We'd like to thank everyone for coming out to both of these events. I received many appreciative comments for having these themed events for our children and families to enjoy. Both evenings we had between 250 - 300 people come out and enjoy the ice and an evening of fun. Pictures from this event and all of our events can be found on the city Webpage when you have time.

We have a very busy schedule for the next month and a half beginning with the Annual Gold Cup Hockey Tournament that begins the Friday, November 25th at 8:00 a.m. and will run through Sunday November 29th with the Championships starting on Sunday at 9:15 a.m. and will run through approximately 2:00 p.m. Friday and Saturday games will run the entire day for you enthusiastic hockey fans.

Please join us at the Dan Kostel Recreation Center on November 29th as the Mayor mentioned, from 6:00 p.m. to 9:00 p.m. after the Holiday Lighting Ceremony for our Annual Holiday Skate. This is a free event for residents and if you would, bring proof of residency with you for your admission.

Our 20th Annual Holiday Christmas Skating Recital will be held Saturday December 12th from 4:00 p.m. to 6:00 p.m. Please make time and come out and watch our Muni Figure Skaters perform.

On December 20th from 3:00 p.m. to 5:15 p.m. we'll have our Holiday Skate with Santa, again prior to the Christmas holiday.

Futsal signup (indoor soccer) will begin December 7th. This is a co-ed program for those five to 14 year olds and runs from January through March.

Don't forget to sign up for a Holiday Grab bag Fitness Class which will begin December 8th. You will need to sign up by December 7th to avoid any late fees. You choose the classes you wish during the holiday season to attend because of the hectic holiday schedule. You can mix or match or take as many as your schedule allows you. All classes are held Tuesdays, Thursdays and Saturdays at Fire Station No. 1.

Learn-to-Skate Sessions, No. 2 for hockey players three to 13 will begin January 2nd, which are held Saturday mornings from 11:15 a.m. to 12:15 p.m. We'll have another free trial on December 19th for those who may be unsure if they wish to participate in hockey. You get a free trial day. Come out and see what you got, so to speak.

Figure Skating Learn-to-Skate Session No. 3 will begin on Tuesday December 8th or Thursday December 10th for your convenience. Early signups for all programs are welcome. For more information for any of the programming please call the Rec Center or visit the Website.

Last, as I presented to Council before the meeting started, you have an overview on the Summer Grass Program. All Council were given a report containing the properties and their respective Wards. This gives you an overview of when we went through the Wards, how many

properties are on the master list, how many were cut by our crews and how many were cut by the residents or outside companies maintaining the properties along with the days and the average cuts per day. The third sheet that was given to you is just a recap of all the other Wards on the whole and you may see to review and see how your individual Ward compares against other Wards as basically I used a percentage system there.

As usual we began the season at the end of April and ended on November 6th. We began the season with 826 properties and ended with 1,056 on the master list. During the season our crews checked 7,186 properties. Again, I reiterated this last year, when they go out and have the master list or whatever route sheets they have every house on the list is checked on a daily basis when they go through the Wards. We cut 1,514 properties or 21% of the properties this year. It was about 5% less than last year so that's a good thing. More people are cutting their properties. There was 5,009 properties that were maintained by the owners or have some type of company maintaining them. About 70% of the properties. The average remains about the same of over the four years this program has been conducted. What is changing is the increased amount of vacant lots from the demolishing of homes by the Land Bank Program which has reached around 55 right now and we're anticipating 90 or 100 possibly so that impact with the work that the grass crew has to do also as they go through the neighborhoods. The other noticeable thing that has happened this year over the past three seasons I think Bill can attest to this, is we finally have owners calling the Building Department to inform the department of the new status of a property or that they have someone maintaining this listed property. We had 119 people call in April and May and the notation was made on the master list and we didn't bother them any more as long as they cut the property and proved that they were cutting their properties. That's about 10% of the overall properties being maintained that normally we would have to go out and check. Basically, we average probably going around each time through the city a three to 3.5 week basis. Of course as the weather gets warmer it slows down a little bit, but as the Mayor had mentioned in other Council Meetings that they did mulching this year, weed pulling over and above what they normally do because a lot of times we were backed up. So if we do get that dry spell those crews are still working in the city as a whole. Again, I think it's a program that the Mayor put into action for four years now. It's working. I think it's a good thing for the city.

Last, if I may, Mr. Chairman, ask a question? Mr. Lamalfa, I understand you voted Yes for my Sergeant-At-Arms position.

CLMN LAMALFA: Yes.

PARKS AND RECREATION DIRECTOR BOB DOBIES: I'm overwhelmed, but I do want you to know I'm a truck driver.

CLMN LAMALFA: Maybe I'd get to watch you throw someone else out instead of me.

PARKS AND RECREATION DIRECTOR BOB DOBIES: Thank you. That concludes my report.

PRESIDENT SUSTER: Thank you, Mr. Dobies. Are there any questions of Mr. Dobies on his report? Mr. Glenn.

CLMN GLENN: Bob, I want to commend you on cutting the grass. You're No. 2 on my complaint list. The first are taxes and second is cutting the grass so you did a good job. Keep it up. I had good response from you. Thank you very much.

PRESIDENT SUSTER: Is there anyone else that has any questions of Mr. Dobies on his report? There being none we will move on to our City Engineer, Dave Krock. Do you have a report for us this evening?

CITY ENGINEER DAVID KROCK: Yes, I do. Thank you, Mr. President. I have some good news to report. The city has received funding for five additional waterline replacement projects. This is a competitive program we submit every year to Cleveland Water and Garfield Heights got five out of the 16 total projects. All the suburbs got so we got a good percentage there. Just over \$1 million--\$1.2 million total. Those streets are listed on your report, but I will read them for everyone else. It's Alexander, Woodward, Maplerow, Darlington and Hillside. Look for those to be done most likely in 2017. It will take a little while to get them there, but it's just like the Turney Road and York and Maple Leaf. Same type of project. We should be doing resurfacing as well at the same time. That's my report.

PRESIDENT SUSTER: Are there any questions of Mr. Krock on his report? Mr. Dudley.

CLMN DUDLEY: That's the section of Maplerow between 126 and 131?

CITY ENGINEER DAVID KROCK: That's correct.

CLMN DUDLEY: All right. Thank you, Mr. Chairman.

PRESIDENT SUSTER: OK. Mr. Glenn.

CLMN GLENN: Did I hear you right? There's going to be waterline and resurfacing on these streets?

CITY ENGINEER DAVID KROCK: Yes, waterline for sure. We expect through the street resurfacing money through Ohio Public Works as well. That will come later. That's why there's a little bit of a delay to match up the funding.

CLMN GLENN: OK. Very good, Dave. Thank you.

PRESIDENT SUSTER: Are there any other questions of Mr. Krock on his report? There being none we will move on to Finance Director, Barb Biro.

FINANCE DIRECTOR BARBARA BIRO: Thank you, Mr. Chairman. I have nothing to report this evening.

SOCIAL SERVICES DIRECTOR KATHY RUSH-PARSSONS: Absent.

PRESIDENT SUSTER: OK. Thank you. Next, we will move on to Economic Development Director Noreen Kuban. Do you have a report for us this evening?

ECONOMIC DEVELOPMENT DIRECTOR NOREEN KUBAN: Yes, I do, Mr. Chairman. I just wanted to give you an update on our Mill Creek Watershed Partnership. You will soon be seeing signs around our community saying that you are entering or leaving the Mill Creek Watershed. This is a campaign to educate the people in our community about the importance of having a healthy watershed. The signs and the educational brochure were developed as part of the Ohio EPA Environmental Education Grant, which the partnership received. Pat Salemi meets regularly with the Mill Creek partners and the group has completed three stream cleanups in Ward 1 with the 4th scheduled for May 7, 2016. As I previously mentioned at the last Council

Meeting the watershed action plan has been submitted to the State EPA and the tree planting mentioned at the last meeting was another Mill Creek Watershed Partnership project. The Garfield Heights Service Department will be posting the signs some time next week and their involvement will serve as the labor to be our grant match. I have copies of the brochure and there are some on the table over there so if Council would like to have copies of the brochure I am passing them out right now. That concludes my report.

PRESIDENT SUSTER: Thank you. Are there any questions of Noreen on her report? Are there any questions for Noreen on her report? There being none, we will move on to Building Commissioner Bill Wervey. Bill, do you have a report this evening?

BUILDING COMMISSIONER BILL WERVEY: No report, Mr. President. I would, however, urge passage of Ordinance 52.

PRESIDENT SUSTER: OK. Thank you. Does anybody have any questions of Bill on his short report?

COMMENTS BY CITIZENS ON THE AGENDA:

PRESIDENT SUSTER: There being none, we will move on to Comments by Citizens on tonight's agenda. Would the Clerk please read the rules?
