

**MINUTES OF A REGULAR MEETING OF COUNCIL  
CITY OF GARFIELD HEIGHTS, OHIO**

Monday, October 24, 2016

**MEETING CALLED TO ORDER AT 7:00 p.m.** by Council President Joseph Suster.

**INVOCATION BY:** Council President Joseph Suster

**READING AND DISPOSAL OF MINUTES:**

**CLMN BURKE:** Mr. Chairman, I would like to make a motion that we accept the Minutes of the Regular Meeting of the City of Garfield Heights Council for Tuesday, October 11, 2016 as written.

**PRESIDENT SUSTER:** On the motion made by Mr. Burke to accept the Minutes of Tuesday, October 11, 2016, all those in favor signify by saying Yea. All opposed?

**COMMITTEE REPORTS:**

**PRESIDENT SUSTER:** Does anybody have any committee reports this evening?

**CLMN NENADOVICH:** Yes.

**PRESIDENT SUSTER:** Mr. Nenadovich.

**CLMN NENADOVICH:** Thank you, Mr. President. For the past two weeks after the last Council Meeting, we had the 2017 Financial Budget Hearings. We had three meetings where the Directors would come and ask for what they would like for next year. There were no Yeses and Nos. It was just what their requests were. Some of the requests, just briefly, as we have on tonight's agenda Mr. Dobies is looking for a Zamboni, Chief Byrne is looking for a Program Standard Operating Procedures, Kathy looking for a bus and a few other things the went on in the Budget Hearings. The Budget Hearings have been held so that we know what our budget will be for next year. Like I said, nothing was set in stone, but they were held according to procedure.

**PRESIDENT SUSTER:** Thank you, Mr. Nenadovich. Mr. Vaughn.

**CLMN VAUGHN:** Yes. Safety Meeting for tomorrow night has been cancelled. We are going to meet in a few weeks. We will be rescheduling it and at that time, we will notify everybody. I think it's obvious the reason why we are cancelling it with the Cavs ring ceremony at 7 o'clock, their

game, the Indians game. It's more important we concentrate on the Indians game so folks, there will be no Safety Meeting tomorrow night.

**PRESIDENT SUSTER:** Thank you, Mr. Vaughn.

**LEGISLATION OUT OF COMMITTEE:** None.

**REPORTS OF THE MAYOR AND DIRECTORS:**

**PRESIDENT SUSTER:** There being none, we will move on to the reports of the Mayor and the Directors. Mayor, do you have a report for us this evening?

**MAYOR VIC COLLOVA:** Yes, Mr. Chairman. Before I get into my monthly report, I would like to once again say that tonight I have the honor and the privilege once again to be bringing on a young man to Garfield Heights finest, our Police Department. We brag about our Police Department because they do such a great job. This young man is going to be coming on to one of the best police departments I think in the area without a doubt. I may be a little bit biased because I'm the Mayor of Garfield Heights, but in all seriousness, with all the negatives and all the positives that go on in this city just like any other city our safety forces (police and fire) get rave reviews all the time. I'm going to turn this over to you, Chief Byrne. Chief, do you want to introduce the young man to everyone?

**POLICE CHIEF ROBERT BYRNE:** Thank you, Mayor and thanks for those kind words. Byron Foxx is the gentleman right here. He is our newest police officer. Congratulations to him. I want to thank him and his family for coming out tonight to show their support for him. Byron is a 19 year veteran of the Ohio State Highway Patrol. He is joining us through the Lateral Transfer Program. I think he's going to be a great addition to our Police Department and obviously, he has some experience. We've had a lot of success with this. These guys that we've hired through that lateral program have been a great addition to our department so on behalf of the men and women of the Police Department, we welcome you, Byron. At that, I'd like to get him sworn in and get him started at work tomorrow.

*(At this time, Mayor Collova swore Mr. Byron Foxx in.)*

**MAYOR VIC COLLOVA:** OK. To continue now with my report tonight, I have a document I'd like to read for everyone.

**Women at Work.** Have you ever thought about a career in the construction trades? This is a great opportunity for those young ladies that would like to get involved in the construction trades. I know my wife always wanted to be a plumber so this is your opportunity. Maybe I can quit working and you can start being a plumber? I think this is a great opportunity.

Council, if you have any of your residents that you can talk to, this is a great opportunity for them.

I want to talk a little bit about the Harvest Fest that was here Saturday. It was a great job put on once again by the staff of Garfield Heights. They put on such a great event it was unbelievable. This is a great day for the kids. I mean they had hayrides. The hayride master was Matt. Clmn Matt Burke was the driver of the hayride. We got no insurance claims so I think we did OK. No, we had a great time. The kids had a ball. There was face painting. There was pumpkin painting. There was decorating. There was bakery of all kinds. Once again, Pat Salemi, Karyn Anel they did a great job along with many others that were involved. I think this is just great that we can have this in Garfield Heights and so many of the families that brought their children there really had a great day. So I thank everyone involved in that. It was really good.

The next thing I want to talk to. I got a couple of calls from residents that were concerned about having Halloween this year. They asked if we would cancel Halloween because of the clowns. There's some kind of a deal now with clowns and I guess it was in the news pretty heavy. I talked to some of the other cities. Nobody seems to be canceling Halloween. This is something that's very special for all the kids. We all enjoyed Halloween back then and it's no different for our kids. They should be able to enjoy this day. It's a one day a year event when they get to go out and get all the candy that we all enjoy after they bring it home. We all enjoy that candy so we are going to have an extra police presence out there. The Chief may talk about it, I hope, in his report. Just be careful. Make sure you keep an eye on the kids. Be careful when you're driving because you know how these young children dart out into the street, etc. so let's keep an eye out for them. Let's make them have a great day- something they're going to remember until next Halloween.

The next thing I want to talk about is, as you can see on Turney Road, there is some sewer work being done to Turney Road. This is in preparation for next year's resurfacing project. Just to give you an idea of some of next year's construction projects, if anybody's in the market to buy stock, if there's any stock out there in orange barrels, this is the time to buy it. This is just a preview of some of the things that are going on next year. Of course we got Turney Road, we got Hathaway Road being resurfaced, we got the widening of Transportation Blvd. bridge, we also have the additional lane on Transportation from the bridge to Granger Road. Some of the side streets that are being done next year is Greenvew, Runnymede, East 117<sup>th</sup>, East 132<sup>nd</sup>, Alexander, Hillside, Maplerow, Richland, Mountview, Darlington and Havana. Along with that, we have the Granger Road Rock Scaling Program that will be going on next year so there will be a lot of construction going on next year. You are going to have to make sure you can figure out how to get from one side of town to the other in a reasonable time, but this is all good news. There is going to be a lot of interruption in the travel, but when we think about what's going to happen the following year with all these brand new projects being completed, this is a huge thing for the city. I'm very proud to have been a part of it.

I also wanted to report I talked with the engineers in the last couple of days and they talked about some of the projects that have gone on in the last five/six years in the city of Garfield Heights. There has been \$30 million worth of projects and most of them road projects. That's something to be said. We have a lot more planned and a lot more coming so as long as we continue to be able to entice industry to come into Garfield Heights and getting construction done in Garfield Heights that increases our taxes and along with the taxes we increase services also so I'm very pleased to report that.

Lastly, before I get into tonight's legislation, I want to say, not that I'm going to be surprising anybody, but Go Tribe! What a great year. When you talk about the Cavaliers, you talk about the Indians, this is something that we have not experienced in a long time. As a long time fan of all the sports in Cleveland, I am as excited as can be. I'm certainly glad that you cancelled tomorrow night's meeting because it would have been the quickest meeting ever. All kidding aside, congratulations to the Indians. Congratulations to the Cavaliers and I hope the Browns can win one game this year and I'd be happy for them.

With that said, we'll get into tonight's resolutions. Resolution 21 is a resolution to apply for the \$2,500.00 Walmart Community Grant to help fund the Annual Shop with a Cop Program. This Shop with a Cop Program has been going on for years and years. It's been spearheaded by Nick DeMarco. He does a fabulous job. All the kids enjoy it. This is something very special and it's something we have been doing for the last few years. We want to continue to support this and apply for this with a Walmart Community Grant. Resolutions 22 and 23 are regards to two different purchasing programs that are designed to save money for the city on joint purchasing participation with other cities. If you need any questions answered, Barb Biro can get into that.

Ordinance 53. We are purchasing a brand new Zamboni. I urge Council to approve this. We've looked at all the options available to us. The Zamboni there is old. It's starting to really break down. Bob's going to get into it a little in his report, but the last time it broke down, we had to cancel ice for a few days. We do not have a spare. The city of Mentor was very kind to donate one of their Zambonis to us so we feel it's important to buy a new Zamboni. We think we got the best price out there. I'm very happy with what the Zamboni Company has done for us. Bob's going to get into that a little further I believe in his report. With that, Mr. Chairman, you have my report.

**PRESIDENT SUSTER:** Thank you, Mayor. Are there any questions of the Mayor on his report?

**CLMN DUDLEY:** Could you tell people what that Zamboni does over there in the Recreation Center? Bob going to do it or you going to do it?

**MAYOR VIC COLLOVA:** Bob will get into that in his report.

**CLMN DUDLEY:** OK, so everybody can know what it is. Thank you, Mr. Chairman.

**PRESIDENT SUSTER:** Thank you, Mr. Dudley. Anybody else have any questions of the Mayor on his report? Next, we'll have the Law Director. Tim Riley's on vacation, but we do have Kevin Weiler here this evening. Kevin, do you have a report for us this evening?

**ASSISTANT LAW DIRECTOR KEVIN WEILER:** Thank you, Mr. Chairman. I don't have any report this evening.

**PRESIDENT SUSTER:** OK. Thank you. Police Chief Bob Byrne. Do you have a report for us this evening?

**POLICE CHIEF ROBERT BYRNE:** Yes, I do, Mr. Chairman. Thank you. The Mayor mentioned next Monday the 31<sup>st</sup> Garfield Heights will celebrate Halloween. The hours are from 6 p.m. to 8 p.m. That's one of those days when a little common sense goes a long way. We would ask that young children be accompanied by a responsible adult. Residents who wish to participate or hand out candy, please leave a light on. To the parents and kids, if there's not a light on, please avoid those houses. Kids and parents please make sure you use the sidewalks.

Motorists, please drive carefully. We will have extra cars out that night. If there are any problems, and I have not heard any other issues with the clowning incidents other than the ones we dealt with earlier in the month and we did make an arrest on that. I know some other communities have made arrests too, so certainly just call 9-1-1. We do have enough people out there to take care of those things.

If you're looking for another alternative for Halloween, there are several police departments in Cuyahoga County in cooperation with the Sheriff's Department is going to have a Halloween event this Friday, October 28<sup>th</sup> from 6:00 p.m. to 8:00 p.m. It's going to be an opportunity for kids to go from police car to police car downtown on Lakeside Avenue, which will be closed off. It's in front of the Justice Center. So the kids can wear costumes. There's free parking at the Huntington Garage and there will be some other things going on there for the kids to enjoy as well.

Last but not least, as the Mayor mentioned, Resolution 21 I would certainly ask for your support. That Shop with a Cop is a great event and I think we've been doing it over 20 years like the Mayor said. Tickets are on sale, which you can get at the Police Department Records Room between 8:00 a.m. and 4:00 p.m. I believe they are here at the Civic Center, the Rec Center. Several businesses throughout the city are selling them. I think they have signs posted in their front windows. The elementary schools as well. The Shop with a Cop date is December 10<sup>th</sup>. That drawing will be the 15<sup>th</sup>. With that, you have my report.

**PRESIDENT SUSTER:** Thank you, Chief. Are there any questions of the Chief on his report? Are there any questions of the Chief on his report? Moving on, we'll move to Service Director, Tim McLaughlin. Do you have a report for us this evening?

**SERVICE DEPARTMENT DIRECTOR TIM McLAUGHLIN:** Yes, I do. Thank you, Mr. President. I only have one thing. Leaf pickup will begin on Monday October 31<sup>st</sup>. We will start one leaf truck in Ward 1 and one truck in Ward 7. We ask you to rake your leaves on the tree lawn, not into the street. It only blocks the sewers and causes more problems. I only want the piles to contain leaves only- no tree branches, grass or debris. As I mentioned last time, those are vacuums. They do not chew up branches, etc. It just causes problems and some repair work. We will go street by street, Ward by Ward. I got some calls today for a pile here, a pile there. It doesn't make sense to run all over and jump from street to street because it makes the process slower. You can bag your own leaves if you want to. You can also put your leaves in your regular dark green rubbish container. You cannot put leaves in the light green recyclables container. If you do, the recycling container will not be picked up. That's all I have.

**PRESIDENT SUSTER:** Thank you. Do we have any questions of Mr. McLaughlin on his report? Are there any questions of Mr. McLaughlin on his report? There being none, we'll move on to Parks and Recreation Director, Bob Dobies. Bob, do you have a report for us tonight?

**PARKS AND RECREATION DIRECTOR BOB DOBIES:** Mr. President and Council Members, good evening. I have a very brief report tonight. First of all, we'll have our Annual Halloween Skate this Saturday October 29<sup>th</sup> from 4:00 p.m. to 6:00 p.m. This is for Garfield Heights residents. We're having it on the Saturday so our children, just as the Mayor mentioned, may enjoy going door to door on Halloween night. Children under 12 will receive candy bags on their way out. All must show proof of residency at the door. Children must be accompanied by an adult. Come and enjoy the evening with skating costumes and music by Smooth Moves.

Our second Figure Skating Learn to Skate session begins tomorrow. There is still time to register if you are interested. Please call the Rec. We have over 30 participants already signed up for the second session.

We will be completing our soccer season this week. Our teams have enjoyed a very mild fall season for a change with very little rain and comfortable. I think we cancelled one game and that was because of lightning and thunder. Our program remains very popular with well over 100 children participating.

Last, I would ask Council to support Resolutions 22 and 23. Barb can probably better explain Resolution 23 with Sourcing Alliance. Resolution 22 is cooperative purchasing. This was introduced to us by the Zamboni Company. It's at no cost to anybody. This is out of Minnesota and when purchasing a Zamboni, Ohio does not recognize through the bid process. A Zamboni is a necessity. Let's put it that way. It was a unique opportunity to happen upon this through a suggestion and as I mentioned, as you read the resolution there is no cost to join this purchasing cooperative. But on the same token, just by joining it you would enjoy a discount on the Zamboni of at least 3%, which is not a lot of money when you are talking \$100,000.00, but it is something. Of course Ordinance 53, which is the authorization to purchase the Zamboni.

If you will, Mr. President, I'd just take questions because I'm sure there are a few. Probably better to answer than go through the whole realm. I did explain some of this at the Finance Meeting. The essentiality of the Zamboni to run the rink because of the purpose that the ice supplants many of the other operations that I have in my Recreation Department. Yes, Sir.

**PRESIDENT SUSTER:** As Mr. Dudley had asked, maybe you could tell everybody what a Zamboni does?

**PARKS AND RECREATION DIRECTOR BOB DOBIES:** I'm sure everybody has seen them on the ice one time or another, whether they're watching TV or down at the Q for an ice game. The Zamboni is the machine that conditions the ice. That's a pretty simplistic thing. It builds ice along with conditioning the ice. Here in Garfield we usually flood our rink. We run the chillers. We usually build ice over about a two week period. We can build it a little bit quicker, but building ice is a process where you build a little bit at a time. With the Zamboni, once you get to a certain level, you can lay the water at certain levels and certain speeds. Usually perfect ice is made about one-eighth to one-quarter inch at a time. OK? That's a building process and that's why it takes so long. The machine is capable of doing those things along with conditioning the ice as to cutting the ice. As time goes on we probably all skated at a neighborhood rink in our areas and you didn't care if the ice was cut or not, but people became very demanding over the years, not only from the professional level but even from the amateur levels. Ice skaters and hockey players they all like different ice. One likes harder ice. The other one likes softer ice. This machine allows us to condition the ice to make, per se, perfect ice. Does it come out perfect every time? No.

The Zamboni machine that we have is a 1998, probably putting in \$30,000.00 over the time that I've been here, including batteries. Batteries alone were \$8,000.00, but with the ongoing process of things aging, as we all experience here not only with equipment but buildings, etc. we're in a situation where I was thinking two years ago of purchasing a Zamboni. The time has come. We are in a good position to do this. It is no different than when I purchased the two service trucks. I'm in a position at the Rec Center where I can do this comfortably. Talked to the Mayor. Talked to Ms. Biro. We think it's a good time. Although I do carryover and I do carry, it can be made up in a short period.

**PRESIDENT SUSTER:** Thank you. Is there anybody else that has questions of Bob on his report?

**CLMN VAUGHN:** Just two, Bob. I realize we're getting this from Paramount, California. Is this the only company that makes Zambonis?

**PARKS AND RECREATION DIRECTOR BOB DOBIES:** There used to be a dealer in Michigan, but Zamboni cut him out. Timmy can attest to this because the Service Department garnished parts for when we do them but you have to wait till about 11:00 in the morning to call them because of the time difference. They are the only supplier right now. You can get used parts here or there, but they are the only supplier right now. They are supposed to reestablish one closer again. This is the issue. There's only two companies that right now that I know of but I believe there might be one more in Europe, but it's either Zamboni out of California or you go to Olympus in Canada. Right now Olympus runs about \$20,000.00 more dollars than the Zamboni does.

**CLMN VAUGHN:** Bob, 250 days?

**PARKS AND RECREATION DIRECTOR BOB DOBIES:** That's the standard. You mentioned it a little bit earlier, Councilman, and what it is is you are not going to Lally Chevy with 300 cars on the lot. These are special made units and they make them as the order comes in. The unique thing was back in September we had some Zamboni issues and I called Brooklyn, which I had borrowed one from. They just purchased one. I have their legislation and I shared it with Barb. They ordered theirs in May and she was all excited because it was September when I had my issue and I was trying to get a Zamboni from them. She said oh, we're getting ours next week. In talking to the gentleman in California, he says they're not getting theirs till the end of November. So I guess it's pretty standard. I guess if it comes quicker, we will benefit by it. What we're looking at is probably at the end of the season we will have a new Zamboni to sit until next season. There's nothing you can do about it, let's put it that way, to speed things up.

**CLMN VAUGHN:** Thanks, Bob.

**PARKS AND RECREATION DIRECTOR BOB DOBIES:** Sure.

**CLMN VAUGHN:** Thank you, Mr. Chairman.

**PRESIDENT SUSTER:** Are there any other questions for Bob? There being none we'll move on to the City Engineer. Dave Krock is not with us tonight, but we do have Fritz Alderman with us. Fritz, do you have a report for us this evening?

**MR. FRITZ ALDERMAN:** Yes, thank you, Council President. The only report I have is on East 135<sup>th</sup> Street. Construction is moving along. We do hope to get the pavement down before winter comes. If not, we have an alternate plan in place to make that street maintainable through the winter. That's all I have, Sir.

**PRESIDENT SUSTER:** OK. Are there any questions for Fritz on his report?

**CLMN DUDLEY:** When they say alternative plans, are they going to cover it or will it still be like that? The gravel still being exposed where they dug up the ground? Is it going to be exposed throughout the winter?

**MR. FRITZ ALDERMAN:** It will be compacted gravel through the winter. It will have all the utilities protected so when the plows come through that it does not damage any of that.

**CLMN DUDLEY:** All right. That's all, Mr. Chairman.

**PRESIDENT SUSTER:** OK. Thank you. Next, we'll move on to Social Services Director Kathy Rush-Parssons. Kathy, do you have a report for us this evening?

**SOCIAL SERVICES DIRECTOR KATHY RUSH-PARSSONS:** Thank you, Mr. Suster. I have nothing new to report this evening.

**PRESIDENT SUSTER:** Moving along, we'll move on to Economic Development Director, Noreen Kuban. Noreen, do you have a report for us this evening?

**ECONOMIC DEVELOPMENT DIRECTOR NOREEN KUBAN:** Thank you, Mr. President. No, I have no report this evening.

**BUILDING COMMISSIONER BILL WERVEY:** Absent.

**PRESIDENT SUSTER:** I don't see Bill down there, right? OK. That's the reports of the Mayor and the Directors. We'll move on to Comments by Citizens on tonight's agenda. Would the Clerk please read the rules?
