



<p>Driver of Unit 1 states that upon approaching the intersection of Antennucci Blve w/b @ Transportation Blvd, the traffic signal was red and Unit 2 was stopped, but quite a distance from the intersection which prevented Unit 1 from making the right hand turn onto Transportation Blvd. Driver of Unit 1 honked horn several times and Unit 2 moved forward slightly then stopped abruptly. Both units eventually made the right hand turn n/b onto Transportaion Blvd. Driver of Unit 1 sped up and tried to pass Unit 2. Unit 2 sped up preventing Unit 1 from passing. Both units entered the on ramp to IR 480 w/b. Driver of Unit 1 went onto berm and passed Unit 2. Unit 2 then struck Unit 1 in the rear end, sped around Unit 1, then sped off w/b. Driver of Unit 1 followed and contacted police. Cuyahoga Heights PD assisted and made contact with both units on Grant Ave awaiting GHPD to arrive.</p> <p>Driver of Unit 2 states that he was stopped at the red light on Antennucci Blvd w/b @ Transportation Blvd waiting to make a right hand turn when Unit 1 began blowing the horn feverishly. Unit 2 made the turn n/b onto Transportation Blvd and then entered the entrance ramp to IR 480 w/b. Unit 1 passed Unit 2 in the berm, got in front of Unit 2, then "Brake Checked" Unit 2 causing Unit 2 to rear end Unit 1. Driver of Unit 2 then sped around Unit 1 to get away from him questioning Unit 1's intentions.</p> <p>The damage to Unit 1 consisted of the rear bumper being uniformly twisted downward as if the rear end was lifting as it was struck by Unit 2. The damage to Unit 2 was minor and high on the front bumper possibly indicating the front end of Unit 2 was dropping from heavy braking. No measurements were taken and this Officer does not have any specialized accident investigation training. This opinion is merely based on observation of the damage and experience.</p>
