

UNIT 1 WAS TRAVELING NORTH ON TURNEY RD. CROSSING THE INTERSECTION OF WILLARD AVE. IN THE CENTER LANE. UNIT 2 WAS ALSO TRAVELING NORTH ON TURNEY RD. IN THE CURB LANE BEHIND UNIT 1. UNIT 1 CAME UPON A CONSTRUCTION AREA WHERE THE CENTER LANE HAD BEEN CLOSED AND ATTEMPTED TO CHANGE INTO THE CURB LANE. THE MIRROR OF UNIT 1 STRUCK UNIT 2'S MIRROR CAUSING DAMAGE.


