



 UNIT 1 WAS TRAVELING EAST ON I 480 NEAR MILE POST 23.2 IN LANE 1. UNIT 2 WAS FOLLOWING DIRECTLY BEHIND UNIT 1, AND UNIT 3 WAS BEHIND UNIT 2. TRAFFIC ON THE ROADWAY WAS HEAVY AND SLOW MOVING. THE DRIVER OF UNIT 3 THOUGHT THAT TRAFFIC WAS BEGINNING TO MOVE BUT TRAFFIC STOPPED AGAIN SUDDENLY. UNIT 3 STRUCK UNIT 2 IN THE REAR. UNIT 2 WAS THEN FORCED INTO UNIT 1.
