


UNIT #1 WAS TRAVELING EAST ON THE IR 480 EXIT RAMP TO TRANSPORTATION IN THE OUTSIDE LANE DIRECTLY BEHIND UNIT #2. UNIT #2 WAS STOPPED FOR THE TRAFFIC LIGHT. AS A RESULT, THE FRONT OF UNIT #1 COLLIDED WITH THE REAR OF UNIT #2. BOTH UNITS WERE MOVED FROM FINAL REST, DRIVERS EXCHANGED INFORMATION AND REPORT TAKEN AT THE STATION.
