

Driver of unit 1 states she was traveling in lane 1 and traffic stopped suddenly in front of her, she swerved to the right to avoid a collision with the vehicle in front of her. As a result of swerving she struck unit 2 as it traveled in lane 2. Unit 1 then re entered lane 1 and struck unit 3 in the rear pushing unit 3 into the rear of unit 4.

Driver of unit 2 states he was traveling in lane 2 and unit 1 swerved into his lane to avoid a collision with unit 3 and as a result struck his vehicle prior to swerving back into lane 1 and striking unit 3.

Driver of unit 3 states she was slowing for traffic in front of her in lane 1 and was struck by unit 1 from behind.

Driver of unit 4 states she was slowing in traffic in lane 1 and was struck in the rear by unit 3 as a result of unit 3 being struck from behind by unit 1.
