

UNIT 1 EXITED THE PRIVATE PARKING LOT ACROSS FROM 4765 E. 131 ST. AND BEGAN TO TURN RIGHT ONTO E. 131. UNIT 1 WAS EQUIPT WITH AN EXTENSION ARM AND THE ARM WAS VERTICALLY EXTENDED. THE ARM STRUCK AN OVERHEAD WIRE HOLDING TWO FLASHING YELLOW TRAFFIC LIGHTS AND PULLED THE WIRE OFF OF THE UTILITY POLE ON THE WEST SIDE OF THE STREET.
