

Narrative

UNIT ONE WAS TRAVELING E/B ON IR 480 EAST, IN THE HIGH SPEED (#1) LANE. UNIT TWO WAS TRAVELING BEHIND UNIT ONE, UNIT THREE WAS TRAVELING BEHIND UNIT TWO AND UNIT FOUR WAS TRAVELING BEHIND UNIT THREE. AS UNIT ONE APPROACHED MILE POST 23.4, IT SLOWED TO A STOP FOR TRAFFIC. UNITS TWO AND THREE STOPPED BEHIND UNIT ONE FOR TRAFFIC. UNIT FOUR DID NOT ALLOW ASSURED CLEAR DISTANCE AHEAD AND STRUCK UNIT THREE IN THE REAR. AS A RESULT OF BEING STRUCK BY UNIT FOUR, UNIT THREE WAS PUSHED INTO UNIT TWO, WHICH WAS THEN PUSHED INTO UNIT ONE.




