





Unit 2 did not stop and was said to be a small red auto driven by a black male with short hair. Witnesses followed the auto to Turney Rd in Bedford and lost it in that area. GHPD did get several calls just before the accident stating a small red auto was heading south on Turney Rd and was driving recklessly. A BOLO was put out and we were contacted by Summit County that they had a auto that crashed on I-271 at mile post 17. The plate was CBY1425 and it had heavy damage to the front. See their report #15-4317. Witnesses Chris Johnson and Scott Erwin both stated that they observed the vehicle driving erratically prior to the crash. After the crash, Unit 2 was observed and followed in speeds greater than 70 MPH. Johnson stated that he observed the first three letters on the rear plate of Unit 2 as CBY or CPY.</p>
