

Narrative

THE OPERATOR OF UNIT 1 STATED THAT SHE HAD A GREEN LIGHT TO TURN WEST (RIGHT) ONTO GRANGER FROM E.105TH. WHEN SHE BEGAN TO MAKE THE RIGHT TURN UNIT 2 RAN THE WESTBOUND RED LIGHT ON GRANGER AND STRUCK UNIT 1 IN THE LEFT FRONT WITH CENTER FRONT OF UNIT 2. THE OPERATOR OF UNIT 2 STATED SHE WAS BLINDED BY THE GLARE OF THE SUN AND COULD NOT TELL WHAT COLOR THE WESTBOUND LIGHT ON GRANGER WAS AND AS SHE WENT THROUGH THE INTERSECTION, SHE STRUCK UNIT 1.
