



 DRIVER OF UNIT #1 STATES THAT SHE WAS MOVING UNIT #1 FROM THE MAIN ROADWAY TO A PRIVATE PROPERTY PARKING LOT DUE TO BRAKE FAILURE. DRIVER WAS UNABLE TO STOP THE VEHICLE FROM STRIKING A STEEL CABLE STRETCHED ACROSS THE DRIVEWAY, AND THEN A LARGE STEEL ITEM ON THE OTHER SIDE OF THE CABLE. THERE WAS NO DAMAGE CAUSED BY THE CABLE, BUT THE VEHICLE WAS DISABLED AFTER IT STRUCK THE SECOND ITEM. VEHICLE TOWED PRIVATELY. DRIVER ARRESTED FOR DRIVING UNDER SUSPENSION.
