

UNIT ONE WAS TRAVELING N/W ON BROADWAY AVENUE (SR 14). UNIT TWO WAS TRAVELING S/W ON MCCRACKEN ROAD AND STOPPED FOR A RED TRAFFIC SIGNAL AT THE INTERSECTION OF MCCRACKEN AND BROADWAY. UNIT TWO WAS WAITING TO MAKE A RIGHT HAND TURN (N/W) UNTO BROADWAY AVENUE. AS UNIT ONE WAS TRAVELING THROUGH THE INTERSECTION, HE ACTIVATED HIS LEFT TURN SIGNAL AND SLOWED IN SPEED. UNIT TWO STATED HE BELIEVED UNIT ONE WAS MAKING THE LEFT HAND TURN TO MCCRACKEN ROAD. UNIT TWO BEGAN TO MAKE A RIGHT HAND TURN UNTO BROADWAY. AS UNIT TWO BEGAN MAKING HIS RIGHT HAND TURN UNTO BROADWAY,
