

UNIT #1 WAS TRAVELLING S/W DOWN WARNER RD HILL AND HAD JUST CLEARED THE CONSTRUCTION BARRELS WHEN A DEER CAME FROM THE EAST SIDE OF WARNER RD (DRIVER SIDE) AND CROSSED DIRECTLY INTO THE PATH OF UNIT #1. THE DRIVER WAS UNABLE TO TAKE EVASIVE ACTION AND STRUCK THE DEER WITH THE FRONT CENTER OF THE VEHICLE. THE DEER WAS THROWN FROM THE ROADWAY AND NOT SEEN AGAIN.
