

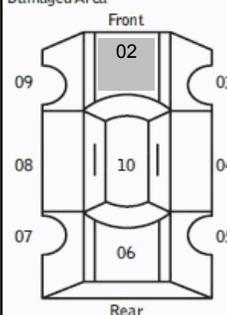

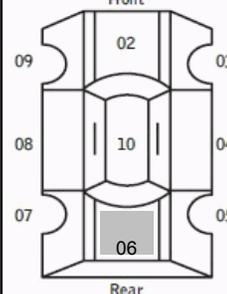
UNIT ONE WAS STOPPED FOR TRAFFIC, AT THE INTERSECTION OF GRANGER ROAD (SR17) AND TRANSPORTATION BOULEVARD. UNIT TWO WAS STOPPED FOR TRAFFIC BEHIND UNIT ONE. DRIVER OF UNIT TWO ADVISED SHE LET HER FOOT OFF OF THE BRAKE, DID NOT ALLOW ASSURED CLEAR DISTANCE AHEAD, AND STRUCK UNIT ONE IN THE REAR, CAUSING MINOR DAMAGE TO THE BUMPER AND LICENSE PLATE.

BOTH PARTIES IN UNIT ONE CLAIMED INJURY. GHFD SQUAD #1 CLEARED BOTH PARTIES, WHO ADVISED THEY WOULD GET CHECKED OUT LATER AT METRO.
