




UNIT 1 STATES THAT WHILE N/B ON TURNEY IN LEFT TURNING LANE, UNIT 2 ATTEMPTED TO GO AROUND UNIT 1 ON THE RIGHT WHEN UNIT 2 CROSSED INTO UNIT 1 LANE AND UNIT 2 STRUCK UNIT 1 ON PASSENGER SIDE. UNIT 2 THEN FLED N/B ON TURNEY. UNIT 1 DID STATE THAT THIS HAD BEEN ROAD RAGE INCIDENT. THIS OFFICER LOCATED A PHONE NUMBER TO UNIT 2 OWNER AND SPOKE WITH A "JAMIE" WHO ADVISED THAT THE REGISTERED OWNER WAS IN THE U.S. NAVY AND THE VEHICLE WAS BEING DRIVEN BY THE OWNERS COUSIN, "MIA". JAMIE WAS ADVISED TO HAVE MIA CONTACT THIS OFFICER AND SHE HAS NOT YET CALLED.
