



Narrative

UNIT 1 WAS STOPPED AT A RED LIGHT ON E. 135 AT GRANGER RD. WHEN THE LIGHT TURNED GREEN UNIT 1 PROCEEDED INTO THE INTERSECTION AND BEGAN TURNING WESTBOUND ONTO GRANGER RD. UNIT 2 WAS TRAVELING WEST ON GRANGER RD. APPROACHING E. 135. UNIT 2 FAILED TO STOP FOR THE RED LIGHT AT E. 135 AND STRUCK UNIT 1 AS IT PASSED THROUGH THE INTERSECTION. UNIT 2 THEN LEFT THE ROAD TO THE RIGHT, TRAVELED ONTO THE TREE LAWN AND STRUCK A TRAFFIC SIGN POST.
