

Narrative

UNIT 1 WAS TRAVELING WEST ON MCCRACKEN APPROACHING THE INTERSECTION WITH TURNEY RD. UNIT 1 WAS PREPARING TO TRAVEL STRAIGHT THROUGH THE INTERSECTION AND ENTERED THE LANE TO PROCEED STRAIGHT. UNIT 2 WAS ALSO TRAVELING WEST ON MCCRACKEN APPROACHING TURNEY RD. THE DRIVER OF UNIT 2 ALSO INTENDED TO GO STRAIGHT THROUGH THE INTERSECTION, BUT UNIT 2 WAS IN THE LEFT TURN LANE. WHEN UNITS 1 AND 2 WERE SIDE BY SIDE, UNIT 2 CHANGED LANES INTO THE STRAIGHT LANE AND STRUCK UNIT 1 CAUSING DAMAGE.
