





 DRIVER OF UNIT #1 ENTERED THE IR480 W/B ON RAMP FROM TRANSPORTATION BLVD AND APPROACHED TRAFFIC AHEAD OF HER THAT HAD STOPPED. WHEN SHE CAME TO A STOP BEHIND TWO OTHER VEHICLES THAT WERE STOPPED, A FEW MOMENTS LATER HER VEHICLE WAS REAR-ENDED BY UNIT #2. DRIVER OF UNIT #2 STATED SHE ENTERED THE ON RAMP AND DIDN'T NOTICE TRAFFIC AHEAD OF HER HAD STOPPED. THUS, HER VEHICLE STRUCK UNIT #1. BOTH VEHICLES WERE ABLE TO BE DRIVEN AWAY AFTER THE CRASH.
