


**Narrative**

THIS OFFICER INVESTIGATED A POSSIBLE INTOXICATED DRIVER AT 5122 TURNEY RD. AFTER SPEAKING TO THE DRIVER OF UNIT # 1, IT WAS DETERMINED BY EVIDENCE, AND CONFESSED BY DRIVER, THAT THE DRIVER OF UNIT # 1 STRUCK A UTILITY POLE AT 9813 SOUTH HIGHLAND IN GARFIELD HTS. CAUSING HEAVY FRONT END AND RIGHT SIDE DAMAGE TO HIS VEHICLE. THE DRIVER WAS LATER ARRESTED FOR A POSSIBLE OVI ( SEE GH2016-0327 INCIDENT REPORT OF ARREST ).
