


Narrative

UNIT 1 WAS TRAVELING WESTBOUND ON SR 17 AT E. 105TH WHEN UNIT 1 LOST CONTROL, RAN OFF THE ROAD TO THE RIGHT, AND STRUCK A FIRE HYDRANT. DRIVER OF UNIT 1 EXITED THE VEHICLE AND BEGAN WALKING WESTBOUND ON SR 17. WITNESS STATED THE DRIVER OF UNIT 1 WAS INTOXICATED. DRIVER OF UNIT 1 WAS LOCATED ON SR 17 AT E. 98TH AND PLACED UNDER ARREST. FIRE HYDRANT WAS NOT DAMAGED IN THE ACCIDENT.
