


Narrative

UNIT 1 WAS TRAVELING THROUGH THE PRIVATE PARKING LOT OF 5764 TURNEY RD. AND WAS FOLLOWING THE INDICATED TRAFFIC CURVE TO APPROACH THE BULIDING. UNIT 2 WAS TRAVELING IN THE SAME LOT AND ENTERED A PARKING SPACE ALONG THE CURVED TRAFFIC LANE. AS UNIT 1 WAS PASSING BY, FOLLOWING THE CURVE, UNIT 2 BACKED OUT OF THE PARKING SPACE AND STRUCK UNIT 1. THE DRIVER OF UNIT 2 STATED THAT THE BACKING LIGHTS ON THE UNIT WERE LIT INDICATING THAT SHE WAS BACKING UP. THE DRIVER OF UNIT 1 DID NOT SEE THE LIGHTS ON UNIT 2.
