

 DRIVER OF UNIT #1 STATED SHE WAS TRAVELLING W/B IN LANE #4 NEAR SR14. ACCORDING TO HER, SHE STARTED TO CHANGE LANES AND SWERVED TO MISS A VEHICLE AHEAD OF HER. WHEN SHE SWERVED, HER VEHICLE SLID OUT OF CONTROL ON THE SNOW COVERED PAVEMENT OF THE BRIDGE AND HER VEHICLE STRUCK THE CENTER CONCRETE BARRIER. AFTER THE CRASH, HER VEHICLE CAUGHT ON FIRE AND WAS A TOTAL LOSS.
