



UNIT #1 WAS TRAVELING ON IR480 W/B APPROACHING THE BROADWAY EXIT (SR14) IN THE #3 LANE AT A HIGH RATE OF SPEED AND RAN OFF THE ROADWAY TO THE RIGHT APPROX. 200' EAST OF MP 23/8, HITTING A CURB THEN DRIVING UP THE EMBANKMENT HITTING A BUSH. UNIT #1 THEN WENT AIRBORN TRAVELING APPROX. 80' IN THE AIR ROTATING TO THE LEFT LANDING ON THE FRONT END SKIDDING ON THE FRONT END THEN SLAMMING BACK DOWN AND COMING TO REST APPROX. 60' WEST OF MP23/8.
