

DRIVER OF UNIT # 1 STATED HE WAS TRAVELING SOUTH ON EAST 115TH ST. AND RAN OFF THE ROAD TO THE RIGHT, STRIKING A UTILITY POLE ( POLE # 52776 ) IN FRONT OF 5250. DRIVER OF UNIT # 1 STATED HE WAS NOT FEELING RIGHT, AND WAS SEEING "DOUBLE" POSSIBLY DUE TO AMBIEN PILLS AND ALCOHOL THAT HE CONSUMED EARLIER IN THE DAY.

\* AS A RESULT OF AN MVA, THE UTILITY POLE AT 5250 EAST 115TH WAS BADLY DAMAGED. THE POLE NUMBER IS 52776. CEI RESPONDED TO THE SCENE, ALONG WITH GHFD.
