

Narrative

UNIT #1 WAS A TRACTOR/TRAILER FLATBED CARRYING ONE 48,000 LB ROLL OF STEEL. DRIVER OF UNIT #1 STATED HE EXITED IR480 AND WAS ON THE EXIT RAMP IN THE RIGHT LANE. HE ALSO STATED UNIT #2 CAME AROUND HIS RIGHT SIDE FROM BEHIND HIM AND STRUCK THE RIGHT FRONT BUMPER OF HIS TRACTOR. NEXT, THING HE KNEW, UNIT #2 SPUN AROUND AND WAS MAKING CONTACT WITH THE RIGHT SIDE OF HIS TRAILER. THEN UNIT #2 CONTINUED TO SPIN AND STRUCK THE RIGHT BERM GUARD RAIL. DURING THE TIME HIS VEHICLE WAS STRUCK, HE PUT ON THE BRAKES AND THE SUDDEN COLLISION CAUSED THE ROLL OF STEEL TO FALL OFF.

THE CRASH AND UNIT #2 WAS TOWED.




