

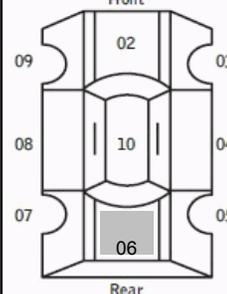

UNIT 2 WAS UNABLE TO STOP IN TIME FOR UNIT 1 CAUSING UNIT 2 TO STRIKE UNIT 1 IN THE REAR. UNIT 1 THEN PULLED OFF OF THE ROADWAY AT WHICH TIME UNIT 2 FAILED TO STOP AND FLED THE CRASH SCENE.
