

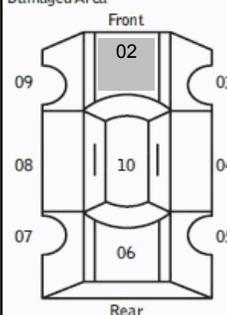

**Narrative**  
 UNIT 1 WAS DRIVING S/B ON THE IR 480 EXIT RAMP AND ATTEMPTED TO MAKE A RIGHT TURN ONTO SR 14 (BROADWAY AVE). THE DRIVER OF UNIT 1 FAILED TO CONTROL THE VEHICLE AND DROVE ACROSS FOUR LANES OF TRAFFIC ON SR 14 AND STRUCK THE UTILITY POLE IN FRONT OF 13600 BROADWAY AVE. NO OTHER VEHICLES WERE STRUCK AND UNIT 1 BECAME DISABLED AFTER STRIKING THE UTILITY POLE. THE DRIVER OF UNIT 1 STATED HIS BRAKES FAILED TO WORK CAUSING HIM TO LOSE CONTROL OF THE VEHICLE.
