

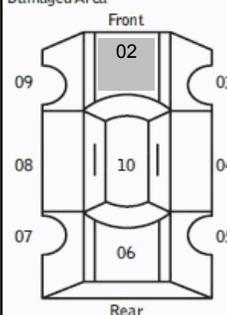

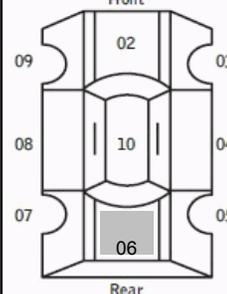
UNIT 1 WAS E/B ON ROCKSIDE AT TURNEY. UNIT 2 WAS BEHIND UNIT 1. UNIT 3 WAS BEHIND UNIT 2. UNIT 1 SUDDENLY STOPPED DUE TO TRAFFIC SIGNAL TURNING RED. UNIT 2 AND 3 WERE ABLE TO STOP IN TIME. UNIT 4 WAS APPROACHING THE REAR OF UNIT 3. UNIT 4 WAS UNABLE TO STOP IN TIME WHEN UNIT 1 STOPPED. UNIT 4 THEN STRUCK UNIT 3 IN THE REAR WHICH CAUSED UNIT 3 TO STRIKE UNIT 2 AND UNIT 2 STRUCK UNIT 1
