





 UNIT #1 WAS STOPPED ON THE SHOULDER I480 EAST NEAR MILEPOST 22/6 JUST BEFORE THE GRANGER EXIT RAMP WAITING FOR AAA TO ASSIST HIM AND WAS STRUCK IN THE REAR BY UNIT #2. UNIT #2 WAS TRAVELING EASTBOUND ON I480 AND STRUCK UNIT #1 IN THE REAR CENTER WITH UNIT #2'S FRONT CENTER WHILE IT WAS STOPPED ON THE SHOULDER. THE FRONT AIRBAGS FROM UNIT # 2 DEPLOYED AND BOTH VEHICLES HAD DISABLING DAMAGE. BOTH DRIVERS WERE TRANSPORTED TO METRO BY GHSD #1 AND #2
