

 UNIT 2 EXITED 480 EAST AT SR 17 EXIT AND WAS TRAVELING ON THE OFF RAMP WHEN UNIT 1 CAME FROM BEHIND AT A HIGH RATE OF SPEED. UNIT 1 STRUCK THE REAR OF UNIT 2 AND PUSHED UNIT 2 INTO THE GUARDRAIL. UNIT 1 THEN CONTINUED TO PUSH UNIT 2 BACK ONTO THE ROADWAY, WHERE UNIT 2 STRUCK THE TRAILER ATTACHED TO UNIT 3. THERE WAS NO DAMAGE TO UNIT 3. ALL 3 UNITS CAME TO REST APPROXIMATELY 1100 FEET FROM INITIAL IMPACT.
