



**Narrative**  
 DRIVER OF UNIT 1 STATED HE WAS TRAVELING EAST ON GARLAND AND ATTEMPTED TO MAKE A LEFT HAND TURN INTO HIS DRIVEWAY. AT THIS TIME UNIT 2 CAME ALONG SIDE HIM AND STRUCK UNIT 1. DRIVER OF UNIT 1 STATED THAT HE UTILIZED HIS TURN SIGNAL. THE DRIVER OF UNIT 2 STATED SHE WAS TRAVELING EAST ON GARLAND AND ATTEMPTED TO PASS UNIT1 BECAUSE HE WAS STOPPED IN THE ROADWAY. AT THAT TIME UNIT 1 STRUCK UNIT 2 IN THE LEFT SIDE. DRIVER OF UNIT 2 STATED THAT UNIT 1 DID NOT UTILIZE HIS TURN SIGNAL. WIT STATED UNIT 1 NEVER STOPPED IN THE ROADWAY.
