





THE DRIVER OF UNIT #2 STATED THE VEHICLE THAT WAS IN FRONT OF HIM SLOWED SUDDENLY WHICH CAUSED UNIT #2 TO MERGE INTO UNIT #1'S LANE CAUSING IT'S FRONT PASSENGER SIDE FENDER TO MAKE CONTACT WITH UNIT #1'S DRIVER SIDE REAR DOOR AND FENDER CAUSING FUNTIONAL DAMAGE TO BOTH VEHICLES.
