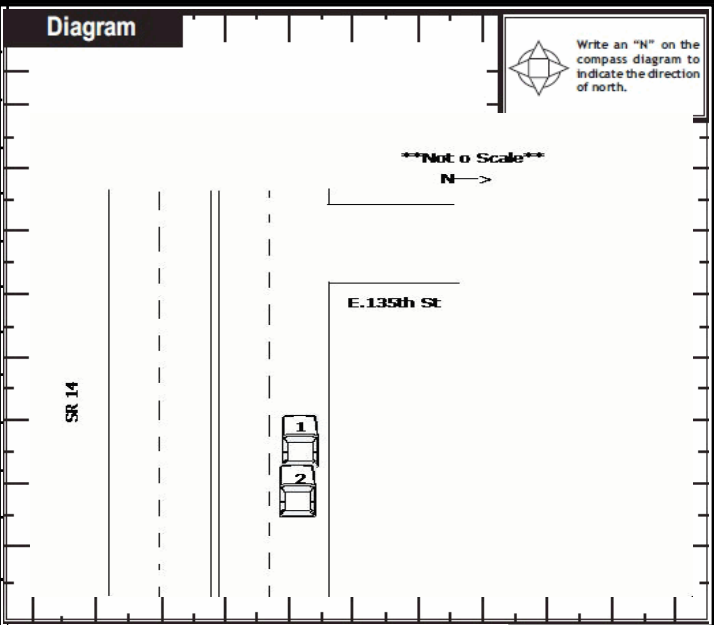

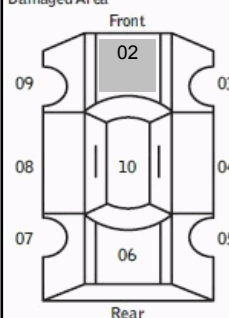

WHEN THE LIGHT TURNED GREEN, UNIT #2 PASSED HER AND CUT RIGHT IN FRONT OF HER. NEXT, SHE CLAIMS HE SLAMMED ON THE BRAKES AND SHE STRUCK HIS AUTO. SHE BELIEVES HE DID IT ON PURPOSE. DRIVER OF UNIT #2 STATED HE WAS IN FRONT OF HER ON SR14 W/B JUST BEFORE E.135TH STREET. HE CLAIMS HE PUT HIS BRAKES ON BECAUSE OF A LARGE WATER PUDDLE IN THE CURB LANE. THIS IS WHEN HIS VEHICLE WAS STRUCK.
