

THE DRIVER OF UNIT #2 STATED THESE FACTS AND STATED THE DRIVER OF UNIT #1 STATED THE CRASH WAS HER FAULT, WHICH SHE ADMITTED TO THIS OFFICER. SHE LATER STATED SHE DID SAY THAT BUT CHANGED HE MIND AND THAT THE DRIVER OF UNIT #2 SWERVED INTO HER.
