



 UNIT 1 WAS TRAVELLING WEST ON IR 480 APPROACHING THE EXIT TO BROADWAY AVE ( MP 23/0). AS UNIT 1 WAS CHANGING LANES, THE SLICK ROADWAY FROM HEAVY RAINFALL CAUSED HIM TO LOSE CONTROL. UNIT 1 RAN OFF ROAD RIGHT, WHILE SPINNING AND STRIKING THE GUARDRAIL ( FRONT END IMPACTED FIRST, THEN CONTINUING TO SPING ALONG THE GUARDRAIL, THE REAR AND RIGHT SIDE ALSO STRUCK)
