





 UNIT 1 STRUCK THE REAR OF UNIT 2, WHICH WAS TRAVELING IN FRONT OF UNIT 1. AFTER BEING STRUCK BY UNIT 1, UNIT 2 AND ITS DRIVER SLID ACROSS HIGHWAY INTO LANE 4 AND CAME TO REST. DRIVER OF UNIT 1 SAID HE WAS DISTRACTED BY A DROPPED CIGARETTE. TWO WITNESSES STATED THAT UNIT 1 HAD BEEN SWERVING ALL OVER THE HIGHWAY PRIOR TO CRASH.
