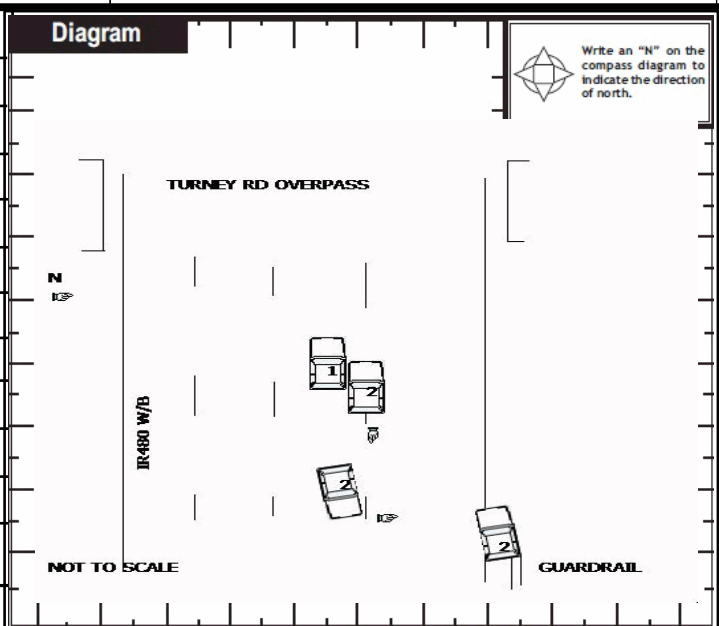





UNIT 2 THEN SPUN 360. UNIT 2 SPUN INTO THE RIGHT SHOULDER. UNIT 2 THEN PLACED VEHICLE IN REVERSE AND STRUCK THE GUARD RAIL END. UNIT 2 THEN FLED THE AREA.
