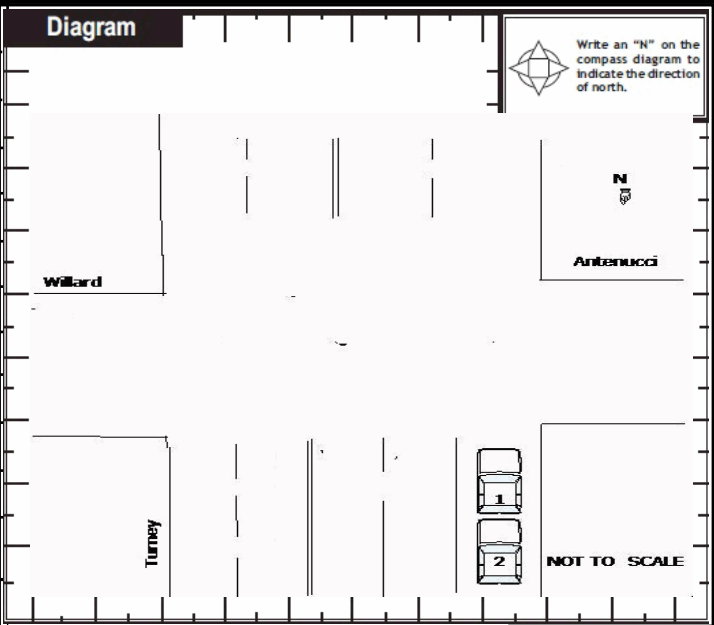

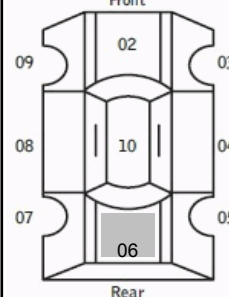

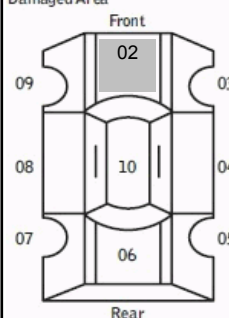

DRIVER OF UNIT 1 STATES HE WAS STOPPED S/B ON TURNEY AT ANTENUCCI FOR THE RED LIGHT AND UNIT 2 STRUCK THE REAR OF UNIT 1. A WITNESS TO THE INCIDENT, GEORGE KARNAVUS, STATED HE WAS IN THE LEFT HAND LANE AND OBSERVED UNIT 2 TRAVELING AT WHAT HE FELT WAS A HIGH RATE OF SPEED FOR APPROACHING A RED LIGHT. UNIT 2 FAILED TO STOP AND STRUCK UNIT 1 IN THE REAR. THE TRAFFIC LIGHT THEN TURNED GREEN AND UNIT 2 TURNED W/B ON ANTENUCCI AND FLED THE AREA, LEAVING THE FRONT LICENSE PLATE OF THE VEHICLE ON THE GROUND AT THE POINT OF IMPACT OF THE TWO VEHICLES.
