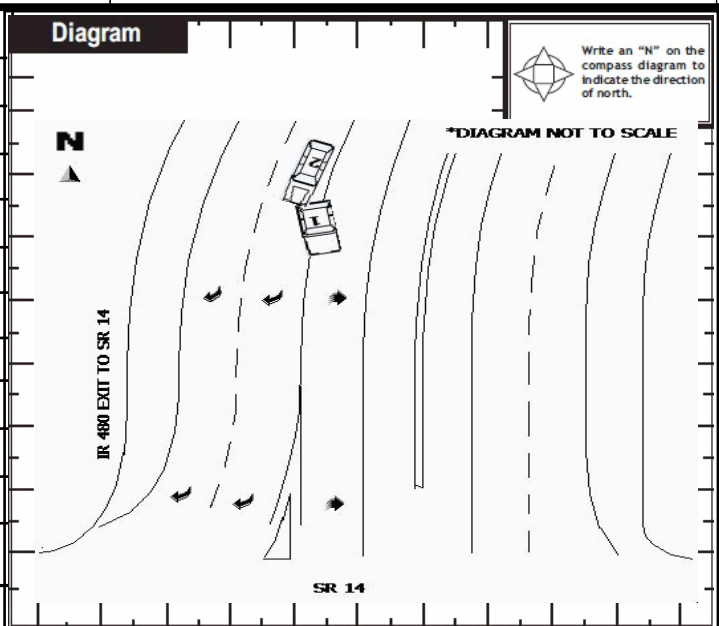



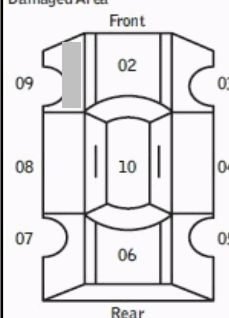

UNIT 1 SLOWED FOR TRAFFIC AND PROCEEDED TO CHANGE LANES TO THE LEFT TURN LANE. AS UNIT 1 WAS COMPLETING THE LANE CHANGE UNIT 2 WAS UNABLE TO SLOW DOWN IN TIME FOR UNIT 1 CAUSING UNIT 2 TO STRIKE UNIT 1 IN THE RIGHT REAR.
