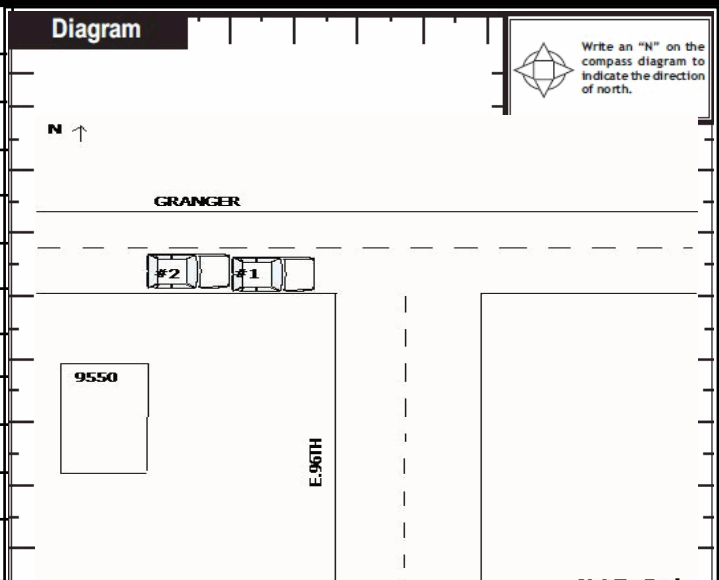

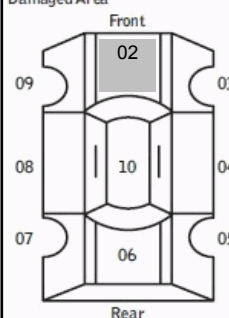


Narrative
