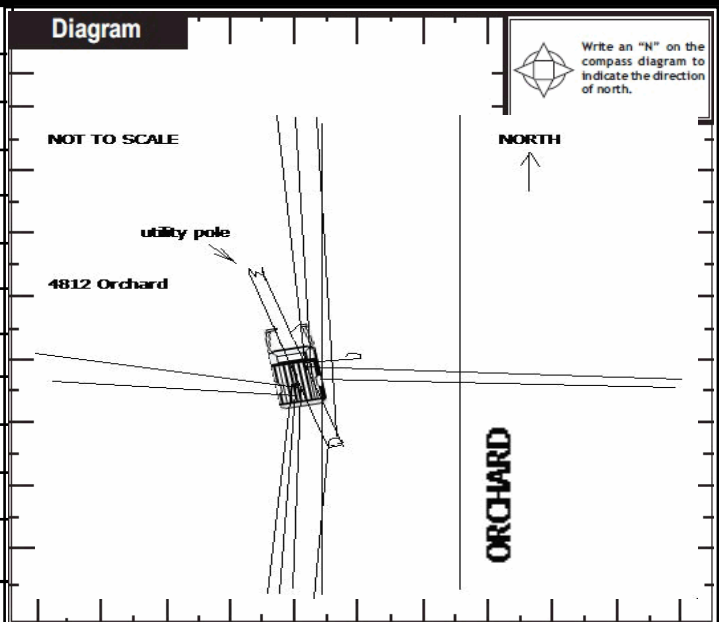

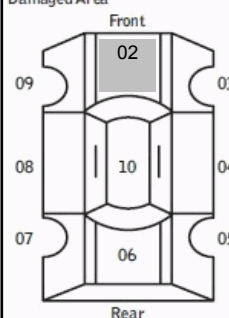

<p>SGT MERCHANT WAS DISPATCHED TO 4812 ORCHARD FOR A M.V.A. UPON ARRIVAL, SGT MERCHANT OBSERVED A RED, DODGE, RAM PICKUP TRUCK HAD STRUCK A LARGE UTILITY POLE LOCATED IN THE FRONT YARD OF 4812 ORCHARD. WITNESSES POINTED OUT THE FEMALE DRIVER AS SHE WAS WALKING NORTH ON ORCHARD. SGT. MERCHANT WORKED HIS WAY THROUGH THE DOWN POWER LINES TO CHECK ON THE CONDITION OF THE DRIVER. THE DRIVER WAS SPEAKING ON THE PHONE AND SHE COMPLAINED ABOUT HER JAW HURTING. THE GARFIELD HTS FIRE DEPT HAD BEEN DISPATCHED TO THE SCENE AT THE SAME TIME AS SGT MERCHANT. THE DRIVER WAS ESCORTED BACK TO THE RESCUE SQUAD TO HAVE HER INJURES TREATED. SGT MERCHANT DID OBSERVE THE DRIVER TO HAVE SLURRED SPEECH, SLOW MOTOR SKILLS AND SHE FUMBLERED TO RETRIEVE HER TEMPORARY DRIVERS LICENSE. DO TO THE DRIVERS POSSIBLE INJURES , NO PHYSICAL TESTS WERE ADMINISTERED AT THE SCENE. THE DRIVERS WELL BEING TOOK PRIORITY OVER THE FIELD SOBRIETY TEST. OFFICER LEE RESPONDED TO ASSIST SGT MERCHANT AND HE RESPONDED TO MARYMOUNT HOSPITAL TO CONTINUE THE INVESTIGATION. SEE INCIDENT REPORT. THE DRIVER CLAIMED THAT HER BOYFRIEND WAS DRIVING THE VEHICLE AT THE TIME OF THE CRASH. A WITNESS THAT HEARD THE CRASH OCCUR STATED THAT SHE WAS THE ONLY OCCUPANT IN THE VEHICLE AND SHE EXITED THE DRIVER SIDE OF THE VEHICLE. THE DRIVER RETURNED TO GATHER BELONGS JUST PRIOR TO SGT MERCHANTS ARRIVAL.
