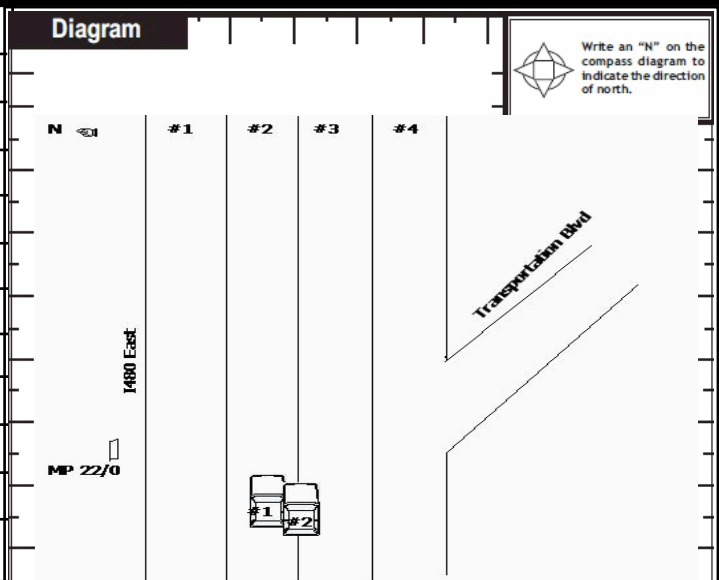



THE DRIVER OF UNIT #1 PULLED OVER TO EXCHANGE INFORMATION AND THE DRIVER OF UNIT #2 FAILED TO PULL OVER AND CONTINUED EASTBOUND. THE DRIVER OF UNIT #1 WAS ABLE TO GET A PLATE NUMBER FOR UNIT #2
