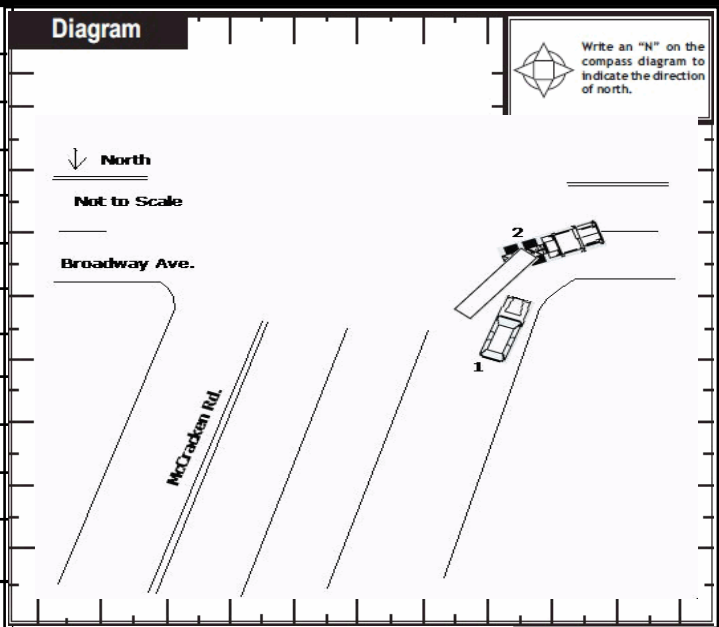

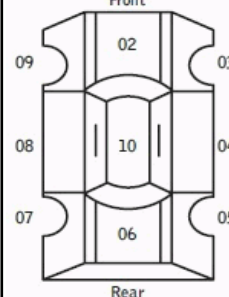

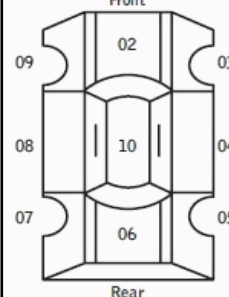

 UNIT 1 WAS STOPPED ON MCCRACKEN RD. AT BROADWAY AVE., IN THE CURB LANE WAITING TO TURN RIGHT ONTO BROADWAY. UNIT 2 WAS STOPPED IN THE CENTER LANE NEXT TO UNIT 1. UNIT 2, AN 18 WHEEL TRACTOR/ TRAILER, THEN ENTERED THE INTERSECTION AND BEGAN MAKING A WIDE RIGHT TURN ONTO BROADWAY. DURING THE TURN THE TRAILER OF UNIT 2 CUT INTO THE CURB LANE AND STRUCK UNIT 1 CAUSING DAMAGE. UNIT 2 THEN LEFT THE SCENE.
