




UNIT 1 WAS TRAVELING EASTBOUND ON ROCKSIDE IN THE LEFT TURNING LANE. UNIT 2 WAS EXITING ONTO ROCKSIDE FROM THE LOT OF 6004 TURNEY. VEHICLES IN THE LEFT AND RIGHT FORWARD LANES STOPPED TO LET UNIT 2 OUT OF THE DRIVE TO MAKE A LEFT TURN, WEST, ONTO ROCKSIDE. UNIT 2 WAS CREEPING THROUGH THE BOTH LANES INTO THE THE THIRD LANE WHICH IS THE LEFT TURN LANE. UNIT 2 DID NOT SEE UNIT 1 APPROACHING AND STRUCK UNIT 1.
