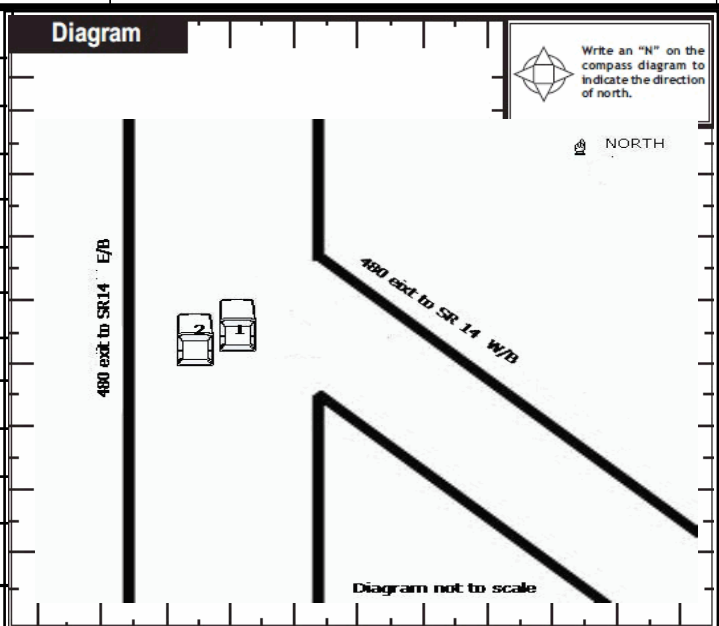

 DRIVER OF UNIT 1 STATES SHE WAS TRAVELING ON THE EXIT RAMP FROM 480 E/B ONTO BROADWAY AND AS THE SINGLE LANE OF TRAVEL BEGAN TO OPEN TO TWO LANES UNIT 2 ATTEMPTED TO PASS UNIT 1 ON HER LEFT. UNIT 2 ENTERED THE SHOULDER OF THE ROADWAY AS IT ATTEMPTED TO PASS HER AND STRUCK UNIT 1. DRIVER OF UNIT 2 STATES THAT HE WAS TRAVELING BEHIND UNIT 1 AND UNIT 1 BEGAN TO MOVE TO THE RIGHT. BELIEVING UNIT 1 WAS CHANGING LANES, UNIT 2 ATTEMPTED TO PASS AND AS HE BEGAN TO PASS UNIT 1 IT SWERVED BACK TO THE LEFT AND THE TWO UNITS COLLIDED.



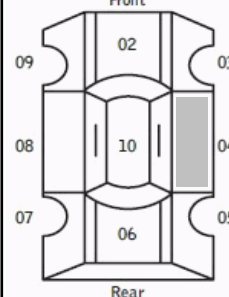
