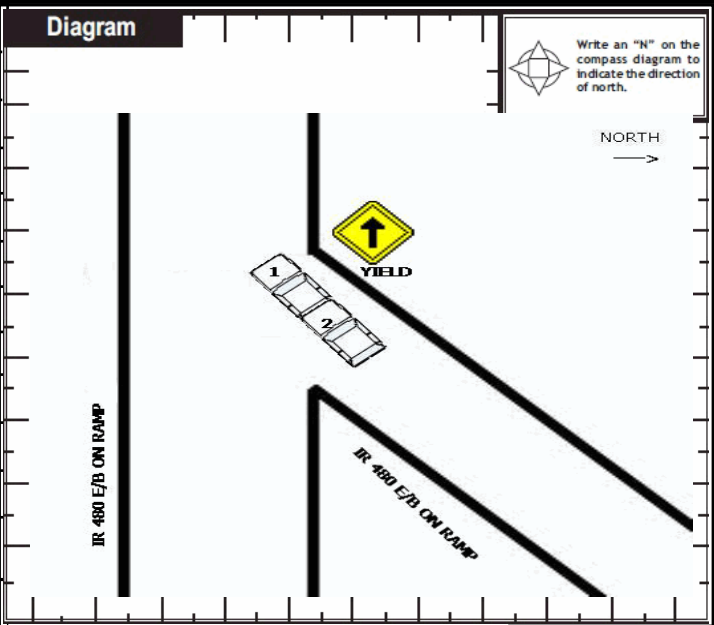

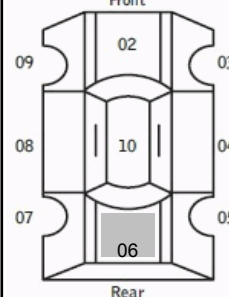

**Narrative**  
 DRIVER OF UNIT #1 WAS TRAVELLING ON THE IR480 E/B ON RAMP FROM TRANSPORTATION BLVD AND APPROACHED A YIELD SIGN. SHE SLOWED FOR TRAFFIC COMING ON HER LEFT AND WAS REAR ENDED BY UNIT #2. DRIVER OF UNIT #2 STATED HE WAS TRAVELLING DIRECTLY BEHIND UNIT #1, DIDN'T NOTICE TRAFFIC TO THE LEFT, AND WAS UNSURE WHY UNIT #1 WAS SLOWING DOWN. HE ATTEMPTED TO SLOW DOWN AT THE LAST SECOND, BUT HIS VEHICLE STRUCK UNIT #1. BOTH VEHICLES WERE ABLE TO BE DRIVEN AWAY AFTER THE CRASH.
