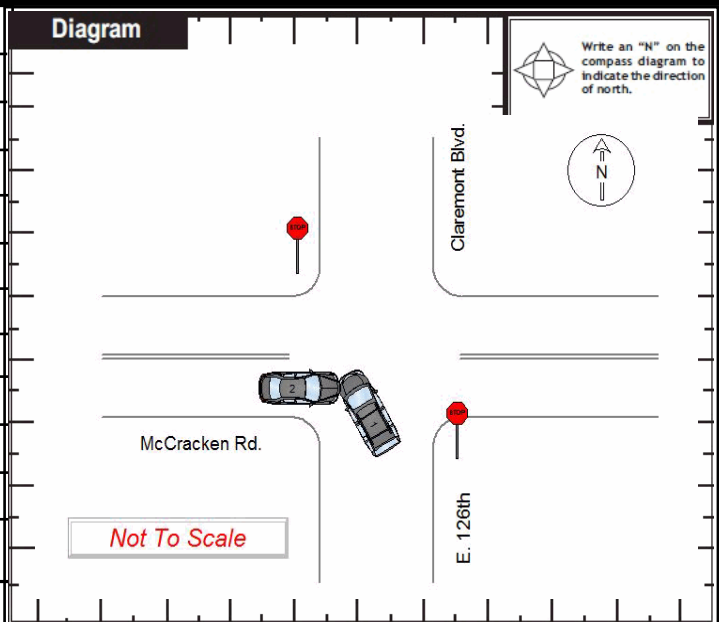




UNIT 1 WAS TRAVELING N/B ON EAST 126TH ST AND STOPPED AT THE STOP SIGN AT THE MCCRACKEN RD INTERSECTION. UNIT 1 THEN STARTED TO MAKE A LEFT TURN ONTO MCCRACKEN RD AND FAILED TO YIELD TO UNIT 2, WHICH WAS TRAVELING E/B ON MCCRACKEN. UNIT 2 STRUCK THE LEFT FRONT AREA OF UNIT 1. THE PASSENGER IN UNIT 1 COMPLAINED OF NECK AND BACK PAIN. BOTH VEHICLES WERE DRIVEN FROM THE SCENE.
