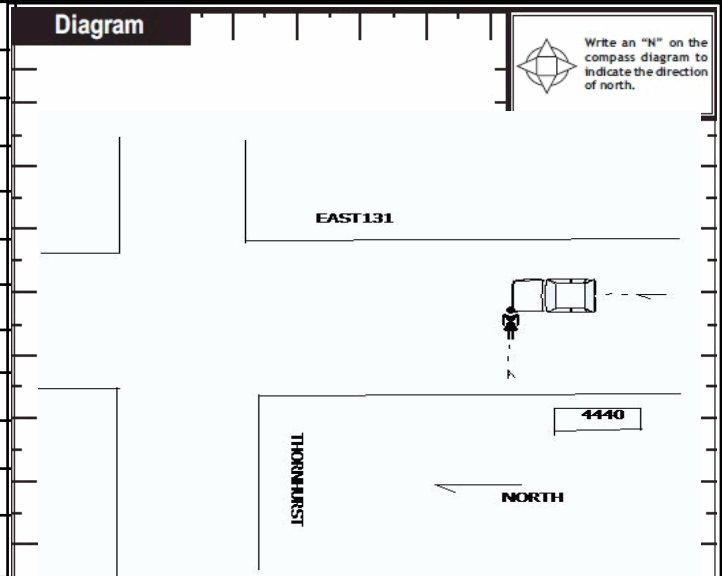


Narrative
