

<p>Officer Lee #007, along with Officer Simia #029, was dispatched to the area of I-480W exit ramp for a report of a accident with injuries. Upon my arrival, Fire and EMS were on scene. I observed a silver car that left the road way to the right and came to rest in the grass between the guard rail and a fence. The vehicle sustained disabling damage, one of the fireman advised me that a male that witnessed the accident was sitting in his truck waiting to speak with me. The male was identified as Nathaniel Hullum, Nathaniel stated when he was exiting I-480W approaching Broadway Ave, he observed a small silver car over in a ditch and a male sitting on the guard rail with blood all on his face. Nathaniel stated he asked the male did he need help, in which the male seemed confused. Nathaniel stated he left the male for a brief moment, to drop off some keys to his coworker who had locked himself out of his vehicle. Nathaniel stated when he returned, the male was gone and at that time he called 911. Officer Simia searched the surrounding streets for the male, while myself and Fire Rescue searched the wooded area for the injured male. Officer Simia, Fire Rescue and Myself was unable to locate the male. A&H Towing was requested to our location to retrieve the vehicle. Once the vehicle was towed, I responded to the address in our city to speak with the registered owner as well as to see if the male had responded to that location as well. Upon my arrival, I was met by a female identified as Eva M. Johnson. I asked Ms Johnson who was driving her car in which she stated her son Aaron Johnson, I advised her of the situation at hand and she stated if and when he return home she will contact me.</p>
